The contractor agrees to pay the amount of \$700.00 USD (seven hundred dollars 00/100 USD). Deposit: (50%): \$350.00 USD. Deposit will be delivered to the signature of this contract. Indispensable to block the date of your event. Balance: (50%): \$350.00 USD. The balance will be settled before the event without exceptions.

IF THE CONTRACTOR REQUIRES MARIACHI IT IS \$700 USD PER SET. THIS QUOTE IS ONLY FOR LOS CABOS, BCS. MEXICO. THIS QUOTE IS ONLY FOR FAMILY PARTIES AND SOCIAL EVENTS WITH A MAXIMUM AUDIENCE OF 300 PEOPLE.

You can negotiate separately with MONICA ROJAS about DJ & mariachi time. In mass events, the price is negotiated depending on the number of people due to the amount of sound equipment. Outside of Los Cabos, the price is negotiated depending on the distance.

The contractor undertakes to provide the following requirements:

- 1. Space within the venue for talent to use as a stage.
- 2. Space within the venue to locate sound equipment and speakers.
- 3. Electrical socket for sound equipment.
- 4. Room space for 8 people.
- 5. Parking for the transport of Talent.
- 6. Other:
- A. If for any reason the contract is cancelled by the contractor, your deposit will not be refunded.
- B. If for any reason the equipment, clothing, equipment or instruments of the talent are damaged by a guest, the contractor will be responsible for the damages and expenses.
- C. If for some reason of emergency, the hired person cannot reach the event (by death or accident), the show will be replaced by a similar show.
- D. The contractor reserves the right to cancel the show in case of verbal, physical or moral aggression towards talent; also, in the event of a mishap which endangers the lives of those employed.
- E. Talent is not responsible for any damage or loss of assigned dressing room items.
- F. It is the obligation of the contractor to investigate whether the City where the event is held requires a special permit, and to process it; the employee is not responsible if the event is interrupted by the authorities.
- G. If for any reason other than that of the contractor the event is suspended (weather, disaster, accident at the event site, etc.), the contractor must terminate the total amount of this contract.
